CHANGE IN BOARD LOT SIZE

The board (the “**Board**”) of directors (“**Directors**”) of Ocean Star Technology Group Limited (the “**Company**”) announces that the board lot size of the ordinary shares in the Company (the “**Shares**”) for trading on GEM of The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”) will be changed from 5,000 Shares to 2,500 Shares with effect from 9:00 a.m. on Thursday, 28 October 2021.

The Shares are currently traded in board lots of 5,000 Shares each and the market value of each board lot of the Shares is HK\$7,350 (based on the closing price of HK\$1.47 per Share as quoted on the Stock Exchange as at the date of this announcement). Upon the change in board lot size becoming effective, the Shares shall be traded in board lots of 2,500 Shares each and the estimated market value of each board lot of the Shares will be HK\$3,675 (based on the closing price of HK\$1.47 per Share as quoted on the Stock Exchange as at the date of this announcement).

As no odd lots of the Shares will result from the aforesaid change in board lot size, no odd lot arrangement is required to be made to match the sales and purchases of odd lots.

The change in board lot size will not result in any change in the relative rights of the shareholders of the Company (the “**Shareholders**”). The Board expects that the reduction in board lot size will lower the threshold for investors to purchase the Shares, thus facilitating the trading and improving the liquidity of the Shares, which will enable the Company to attract more investors and therefore broaden the shareholders’ base of the Company. As such, the Board is of the opinion that the change in board lot size is in the interest of the Company and Shareholders as a whole.

Save and except for the change in the number of Shares for each board lot, the new share certificates (for Shares in board lots of 2,500 Shares each) will have the same design and colour as the existing share certificates (for Shares in board lots of 5,000 Shares each).
